This case came on for trial on the claims of the Plaintiff Jerry Collins, Executor for the Estate of Judy Helen Collins, with the Honorable Judge Christopher Wagner presiding before a jury of eight members – which trial commenced on September 9, 2024.

At the trial, the Plaintiff asserted his claims against the Defendants as follows:

- a. Against the Defendant Robert Graydon Bradley, MD ("Dr. Bradley"), the Plaintiff asserted claims for medical malpractice survivorship, survivorship loss of consortium, and wrongful death; and
- b. Against the Defendant Sean Litherland, MD ("Dr. Litherland"), the Plaintiff asserted claims for medical malpractice survivorship, survivorship loss of consortium, and wrongful death.

The parties stipulated that in the event of a verdict for or against Dr. Bradley, any such verdict would also be deemed to be a verdict for or against, as the case may be, the Defendants TriHealth, Inc. and TriHealth Surgical Institute. The parties further stipulated that in the event of a verdict for or against Dr. Litherland, any such verdict would also be deemed to be a verdict for or against, as the case may be, the Defendant TriState IMG (Imaging Medical Group), Inc. and TriHealth, Inc.

And the jury returned its verdict on September 20, 2024, and with its verdict, the jury found as follows:

- a. The jury found in favor of the Plaintiff and against the Defendant Robert Bradley, MD in the total amount of \$2,063,255.51. This award is the sum of the following amounts awarded by the jury on the Plaintiff's claims against Dr. Bradley:
 - i. \$863,255.51 for Plaintiff's medical malpractice survivorship claim on behalf of Judy Collins which amount was \$363,255.51 for medical bills and \$500,000 for pain and suffering;
 - ii. \$500,000.00 for Plaintiff's survivorship loss of consortium claim; and
 - iii. \$700,000.00 for Plaintiff's claim for wrongful death.
- b. With respect to the Plaintiff's claims against the Defendant Sean Litherland, MD, the jury found in favor of Dr. Litherland, MD, and against the Plaintiff on all of the Plaintiff's claims against Dr. Litherland.

BASED UPON THE FOREGOING, IT IS, THEREFORE, ORDERED, ADJUDGED, AND DECREED as follows:

- 1. With respect to the claims arising from the allegations against Dr. Bradley, judgment is hereby entered in favor of the Plaintiff and against the Defendants Robert Bradley, MD; TriHealth, Inc., and TriHealth Surgical Institute, jointly and severally, in the total amount of \$2,063,255.51.
- 2. With respect to the claims arising from the allegations against Dr. Litherland, judgment is hereby entered in favor of the Defendant Sean Litherland, MD, the Defendant TriState IMG (Imaging Medical Group), Inc., and TriHealth, Inc., and against the Plaintiff on all of the Plaintiff's claims against them that arose from the allegations against Dr. Litherland.
- 3. As the non-prevailing parties, the Defendants Robert Bradley, MD, TriHealth, Inc., and TriHealth Surgical Institute shall pay all court costs.
- 4. The claims against the Defendants Bethesda North; Bethesda, Inc.; and any and all John Doe Defendants are dismissed with prejudice.

5. No claims of Plaintiff remain unresolved except that Plaintiff filed a motion for prejudgment interest on October 4, 2024 which motion is pending as of the date of this entry.

There shall be a report conference on October 31, 2024 for the purpose of (among other things) scheduling further proceedings on the Plaintiff's pending motion for prejudgment interest. The Court will send separate notice to the parties with respect to this report.

IT IS SO ORDERED.
